### July 3, 2009

### Water Supply Outlook

The winter snowpack was a little below average but melted quite slowly. Rainfall in May and June has been very low in the mountains resulting in below average runoff to July 1st. As of July 1st:

- TransAlta's reservoirs are below average;
- Bow River Irrigation District reservoirs are above average, near full;
- our reservoirs are all full.

The irrigation demand to date has been higher than the last 6 years, but not extreme. On average, farmers have used 6" per acre.

Projecting ahead for the next 2 months, with below average precipitation both here and in the mountains, we feel we will be able to meet the irrigation demand. However, we will have to be careful to not waste water. One of the key ways to prevent wasting of water is to communicate with the Water District Supervisor (Ditch Rider); ie. ordering water at least 24 hours in advance and providing 24 hours notice of your plan to stop irrigating.

If a landowner takes water without ordering in advance he is charged with 2 additional days of water use. If it is in an area where this shorts other farmers, his gate will be locked.

If a landowner shuts off with little notice he is charged with the water until the canal can be adjusted to accommodate his shutoff (12-24 hours).

If a landowner shuts off without any notice he is charged until the Ditch Rider notices and adjusts the water. This could be 2 or 3 days.

The District's water supply demand is based on supplying 18" - 20" per acre on average. Our rule of a maximum of 24" allows some parcels to go up to 33% over average knowing that the majority of parcels will be under the 18". At this time, it is the District's intent to enforce the 24" per acre maximum on any irrigable unit (parcel). If a farmer wishes to go above 24" on any parcel this will only be allowed if he limits his water use to 18" on his entire farm.

#### Example:

Farmer X has 4 parcels:

- Parcel (1) 130 acre pivot (wheat)
- Parcel (2) 130 acre pivot (canola)
- Parcel (3) 140 acre flood (alfalfa)
- Parcel (4) 60 acre flood (irr. pasture)
   Total 480 acres

If Farmer X feels he needs more than 24" on parcel (4), he will be allowed only if his total water use is below 18" per acre (720 acre feet). This could be done as follows:

- Parcel (1) takes 12" (130 acre feet)
- Parcel (2) takes 16" (173 acre feet)
- Parcel (3) takes 18" (210 acre feet)
- Parcel (4) takes 30" (200 acre feet)
  Total 713 acre feet

As of June 28th, the average delivery was 6" per acre, however a few farmers are nearing or at the 24" maximum, and a few more (1.4% of parcels) are over 18", and a further 4% of parcels are over 12". If you feel you have used quite a bit of water, get a hold of your Ditch Rider or Superintendent and they will tell you where you are at.

 A 1000 gal/minute pivot (2.25 cfs) uses 4.5 acre feet/day; therefore if you have 130 acres it takes 43 days to use 18" and 58 days to use 24".



 A flood field taking 6 cfs uses 12 acre feet/day; therefore on 140 acres you have 17 days for 18" and 23 days for 24". However, if you take 10cfs you are using 20 acre feet/day and only have 14 days to use 24".



## **Irrigation Development Applications**

Over the past five years on-farm conversions to a more efficient method of irrigation have saved more water than the increase in assessment, therefore the District will accept applications to irrigate additional land in areas without reservoir support, as well as those below Lake Newell and Crawling Valley.

Applications must be received by October 9, 2009 to be considered in this special review.

All successful applications must pass the District's Irrigation Development Criteria, where higher scores are given to the following:

- Irrigable units (parcels) with existing irrigation requiring less than 50 acres of new irrigation (intensification);
- good soils;
- efficient delivery to the parcel and an efficient method of irrigation.

Applications must be received by October 9, 2009.

Capital Asset charges for acres added through efficiency gains and intensification (less than 50 acres per irrigable unit where there is existing irrigation) will be \$300/acre.

Capital Asset charges for new parcels or parcels receiving more than 50 additional acres will be \$700/acre.

### **EIDNet Internet - Lower Rates - Faster Speeds**
