1. This is my completed application and I am enclosing the \$25 reservation fee plus full payment for the group camping area(s) times number of nights, payable to the Eastern Irrigation District (the "EID").
2. I hereby accept the rules as outlined in this application form including the terms and conditions set out in the Daily Camping Rules and Regulations.
3. Reservation applications will be considered on a "first come, first served" basis for any time period during the current campground season and the immediately following campground season. No reservation can be made for any time period during the off season, nor for any individual campsites within or outside of the group camping areas.
4. Reservations may be made directly with campground staff, or by calling the District office at (403) 362-1400. When reserving by phone, reservations will not be confirmed until receipt of payment.
5. Payments by cash, credit card, or debit are accepted at the campground and at the EID's main office. If payment in full is not received with the reservation application, the application will be denied.
6. Either or both of the two group camping areas: sites A to E, and/or sites F to J may be reserved at the discretion of District staff. All five sites within the group area or areas must be paid for (no partial reserving), at a minimum of 2 nights and a maximum of 14 nights.

7. A maximum of 5 camping units (RV's, campers, tents, etc.) can occupy a group camping area. All camping units must be situated in compliance with the campground rules.
8. The campground area(s) will be available by noon on the first day of the reserved time period, and must be vacated prior to noon on the last day of the reserved time period.
9. All campground rules apply to the group camping areas.
10. If the cancellation notice is received by District staff not less than 14 days prior to the first day of the reserved time period, the fees paid less \$100.00 will be refunded (\$100.00 will be retained by the EID).  
  
If the cancellation notice is received by District staff less than 14 days but 7 or more days prior to the first day of the reserved time period, the fees paid less \$200.00 will be refunded (\$200.00 will be retained by the EID).  
  
If the cancellation notice is received by District staff less than 7 days prior to the first day of the reserved time period, no refund will be issued.  
  
No refund will be issued for early departure or if any camper is requested to leave the campground.
11. The EID reserves the right to cancel any reservation for any reason deemed appropriate in the EID's sole discretion. In the event of cancellation by the EID, the full amount of the fees paid will be refunded.
12. Only records pertaining to approved reservation applications will be maintained. No waiting list will be kept.
