- 5. Subject to the outcome of the draw and campsite selection processes, the EID will enter into a maximum of one Seasonal Campsite Use Agreement per camping unit's registration. Only the registered owner(s) of the camping unit may apply for a seasonal site, and that unit must occupy the site.
- 6. My application if deemed eligible in the sole discretion of the EID, will be entered into a draw to be conducted by the EID. If deemed ineligible, the EID's only obligation to me is to return my **\$500.00** application fee.
- 7. The deadline for receipt of an application at the EID's office is 5:00 p.m. on **Friday, March 28<sup>th</sup>, 2025**. Any application received by the EID after this date and time will not be included in the seasonal campsite draw. (Mailing address: P.O. Box 128, Brooks, AB T1R 1B2).
- 8. On **Wednesday, April 2<sup>nd</sup>, 2025 at 7:00 p.m.** <u>at the EID main office</u> at 550 Industrial Road West, Brooks, AB the EID will hold an <u>irrigator</u> campsite selection meeting where the EID will sequentially draw names from the eligible applications up to the number of campsites the EID designates as being available for occupancy on a seasonal basis (the "seasonal campsites"). On **Thursday, April 3<sup>rd</sup>, 2025 at 6:00 p.m.** <u>in the mezzanine at the JBS Canada Centre</u> at 323 1<sup>st</sup> St East, Brooks, AB the EID will hold a <u>public</u> campsite selection meeting where the EID will sequentially draw names from the eligible applications up to the number of campsites the EID designates as being available for occupancy on a seasonal basis (the "seasonal campsites").
- 9. 35 of the 152 sites will be made available as seasonal sites. Of the 35 seasonal sites, 50% (18 sites) will be held for irrigators. Should less than 18 irrigators apply, the remaining sites will be made available to the general public.
- 10. If I am personally unable to attend the campsite selection meeting, I may, in writing, authorize another person to attend the meeting ("my authorized representative") and to act in my behalf. I understand that such person must deliver my written authorization (available on EID website) to an EID representative **before 7:00 p.m. on April 2<sup>nd</sup>, 2025** in order to be allowed to act in my behalf.
- 11. I agree to attend the campsite selection meeting either personally or by authorized representative. If I am not personally in attendance or my authorized representative is not in attendance at the commencement of the campsite selection meeting I will automatically forfeit my opportunity to participate in the seasonal campsite draw and if my name is drawn, I will forfeit my \$500.00 application fee to the EID.
- 12. If my name is drawn and I am present either personally or by my authorized representative, I will be given a time-limited opportunity (not to exceed 3 minutes) to choose from the seasonal campsites remaining at the time of my turn.

- 13. I understand that if I am given an opportunity to choose a campsite and fail to do so within the limited time allowed, I will have lost my opportunity to choose a campsite and my **\$500.00** will be forfeited to the EID.
- 14. If I fail to execute a Seasonal Campsite Use Agreement and to pay the balance of the seasonal campsite fee by **5:00 p.m. on Friday, April 11<sup>th</sup>**, **2025**, I will forfeit my opportunity to occupy that campsite and my **\$500.00** application fee will be forfeited to the EID.
- 15. If my name is drawn and I properly choose a seasonal campsite, enter into a Seasonal Campsite Use Agreement, and pay all amounts owing, my **\$500.00** application fee will be applied to the seasonal campsite fee for my seasonal campsite.
- 16. If my name is not drawn or if there are no seasonal campsites remaining available when my name is drawn, the EID's only obligation to me is to return my **\$500.00** application fee.
- 17. I understand that Rolling Hills Reservoir is an irrigation storage reservoir and water levels may fluctuate throughout the season without notice to meet the needs of the irrigation distribution system.
- 18. If, prior to submitting this application, I mark any of the following group or groups of seasonal campsites, that means that I am **NOT** willing to enter into a Seasonal Campsite Use Agreement for any seasonal campsite in that group or groups. If my name is drawn and the only seasonal campsites remaining available are in the group or groups marked below, my name will automatically be withdrawn from the seasonal campsite draw and the EID's only obligation to me is to return my **\$500.00** application fee.

I will **NOT** enter into a lease agreement for any campsite in the following group or groups:
